Conner is currently active in the house as the risk manager.











After a wonderful 125th Anniversary celebration last fall, 2020 has been a very unique year in Cal Beta SAE history. In March, with the onset of the COVID pandemic, most residents at 2722 Bancroft Way moved back to their homes to shelter in place and attend online classes. A handful of graduating seniors stayed around to make it through to their virtual graduation and there were no reported cases of COVID in the House.

During this past summer, members, sorority coeds and other boarders attending summer school virtually lived in the House. Fortunately, we again had no reported COVID positive cases in the House.

We prepared the House for the Fall semester with a full house of students attending online classes by adding exercise equipment in the Quad, renovating the sundeck, adding new BBQ's for outdoor cooking, and stepped up cleaning services. In September, some residents had positive COVID tests and the House voluntarily had everyone quarantine. The few students who had the virus had very minor symptoms and recovered quickly.


Thankfully we have had Alums and Members step forward throughout our history. During these challenging times, we appreciate your continued involvement and support for Cal Beta more than ever!

# Rocky Gunderson '72

Rocky Gunderson pledged Cal Beta SAE in Fall of 1972. He hadn't considered fraternities into his plans at Cal but was persuaded by a high school friend, John McIntosh, to go through rush with him. It was clear that SAE was the class of

the fraternities he visited during rush. Both John and Rocky ended up pledging SAE and the rest Is history! In his 4 years living in the house, Rocky served as the Treasurer his junior year and as Eminent Archon his senior year. While at Cal, Rocky kept busy playing football and rugby.

Rocky graduated in June, 1976 with honors (Tau Beta Pi) with a BS in Engineering. He then went on to Stanford to get his Masters degree in Engineering and later, to UCLA to get his MBA. At UCLA, Rocky was awarded the Ford Scholarship as the top performer in his business school class. It was at UCLA that Rocky met his future wife, Mary Jo Miller. Rocky and Mary Jo moved to Northern California after business school to work for Hewlett Packard and they were married 2 years later and have been happily married for the past 38 years. Rocky and Mary Jo currently live in Cupertino, but Rocky's work has taken him all over the world including moving his family to The Netherlands to live and work for 3 years for a Dutch start-up (Baan) as the VP of Product Marketing and Product Management. As it turned out, that was a very successful business venture as Rocky helped take Baan public in 1995. They grew Baan to over \$1B in global software sales over the next 5 years. Since moving back to the states, Rocky has co-founded a company and has been an advisor to numerous start-ups and midsized companies. In addition, Rocky was the Chair of the Investment Committee of the UCLA Venture fund for 5 years, where he drove the Fund's investment in 15 start-ups. Currently, Rocky advises small and medium sized hardware and software companies on optimizing and scaling their supply chains and sales and marketing operations as a Senior Consultant with OnTap Consulting.

Rocky and Mary have two children, Matt, who was an SAE at UCLA and Jenna, a Varsity Water Polo player at Stanford. After working with a successful health care start-up, Matt went on to get his MBA at the Haas School of Business and now serves as the VP Finance at a really cool Austin based cookware start-up called Made-In. She returned to work in product marketing for Pandora and after that for Sony in their streaming media service Playstation Vue. Jenna recently joined

Jeff Koblick recruited Rocky onto the House Corporation Board in 2011 at a Cal football game they were attending together. Rocky served on the Housing Board in various roles until 2019. According to Rocky, "It was great to get back into the house and work with the students, as well as to help the Board maintain and enhance one of the best places to live on campus. We definitely had some challenging times with the University and with National, but each year, the Board stayed focused on maintaining high standards for student living, while also providing support and advice to the SAE leadership team. It was a pleasure and honor to join a team of dedicated volunteers who had shepherded the house through so much, but when you have lawyers, real estate experts, architects, CFOs and very successful professionals as board members to work with, there are no challenges that cannot be successfully managed through."

In 2019, the 2722 Bancroft Foundation was created as a not-for-profit 501(c)(3) corporation where Rocky currently serves as its President, along with Jeff and Bill Rogers. Those alumni believed that we needed to establish an organization separate from the SAE Housing Corp. This provides an opportunity for our members to take full advantage of their time at Cal to achieve their educational dreams, leading to success professionally, socially, and philanthropically. Our alumni can donate to this worthy cause and get a tax deduction. The Foundation plans to work with students that need help to fully take advantage of their incredible opportunity at Cal. With Rocky's strong entrepreneurial background, he is very excited in particular to build programs that encourage young SAEs to develop and pursue their business dreams while at Cal. Along with his consulting work, Rocky spends as much time as possible at his cabin in Lake Tahoe with Mary Jo and their Golden Retriever, Buster.
